Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:

How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons North Star Community Credit Union chooses to share; and whether you can limit this sharing.

- Alaska, Illinois, Maryland and North Dakota Members: We will not share personal information with nonaffiliates either for them to market to you or for joint marketing without your authorization.
- California Members: We will not share personal information with nonaffiliates either for them to market to you or for joint marketing without your authorization. We will also limit our sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us.
- Massachusetts, Mississippi and New Jersey Members: We will not share personal information from deposit or share relationships with nonaffiliates either for them to market to you or for joint marketing without your authorization.
- Vermont Members: We will not share personal information with nonaffiliates either for them to market to you or for
 joint marketing without your authorization, and we will not share personal information with affiliates about your
 creditworthiness without your authorization.
